General Description

Type of material: Polyester based 2-component filler, styrene-reduced (SR)

Applications: Automobile repairs, carpentry, furniture industry, painting and

> varnishing. When applying filler to wood outdoors, swelling and shrinking of the wood may in principle lead to flaking. Also refer to Data Sheet no. 18 of the Bundesausschuss Farbe und Sachwertschutz (BFS), Frankfurt [German Federal Commission for protection of paint

and material assets].

Product properties: 2-component PE filler SR is used to level major indentation and

> unevenness. It may also be applied as thick layers on vertical surfaces, using a putty knife. Excellently suited for panel beating, chassis building and mould production. Also suited for gluing marble and artificial stone to steel and for repairs to damaged timber (interior) and

chipboard (interior).

Substrate preparation:

The substrate must be stable, dry, clean and with no separating

substances (oil, grease, wax).

Suitable substrate: Sheet steel, cast iron, marble, wood and artificial

stone.

2-component PE filler SR is not suited for zinc-plated and hot-dip

galvanised sheet metal.

Substrates that may be etched with nitro thinners are not suitable (e.g.

acrylic coatings).

Wash primer, synthetic resin or nitro-combination primers are <u>not</u> <u>suited</u> as substrates for 2-component PE filler SR, since these substrates are likely to impair adhesion. Tropical timber such as teak or palisander have components that may seriously delay or even prevent hardening of polyester. Do not apply on strongly alkaline substrates, such as concrete stones and plasters containing cement (risk of saponification).

The preparation of substrates and coating methods should be state of the art. Please in this respect also take note of the BFS data sheets and the VOB [German Construction Contract Procedures]. Part C. DIN

18363, Painting and Coating.

Application: Thoroughly mix the required quantity of filler with ca. 2% hardening

paste and apply within the next 4 – 5 minutes.

2-component PE filler SR may be ground wet or dry after allowing a

further 20 – 25 minutes for hardening.

Overdosing hardening paste will not accelerate polymerisation and may under unfavourable circumstances even cause colour changes in

the covering layer of varnish.

Apply a trial coating before actual application.

Cleaning your tools: Use universal dilution.

Storage: Dry, cool and frost-protected. Re-seal opened container well.

VOC-Value: EU limit for this product (Cat. B/b):

250 g/I VOC (2007).

This product contains no more than 60 g/I VOC.
